65.01 THROUGH STREETS – STOP. Every driver of a vehicle shall stop, unless a yield is permitted by this chapter, before entering an intersection with the following designated through streets.

(Code of Iowa, Sec. 321.345)

1. U. S. Highway No. 169 (Fourth Street) within the City.
2. Chestnut Street from the west corporate line to Second Street.

65.02 STOP REQUIRED. Every driver of a vehicle shall stop in accordance with the following:

(Code of Iowa, Sec. 321.345)

1. First Street. Vehicles traveling south on Second Street shall stop at the intersection with County Road F-31.
2. Second Street. Vehicles traveling south on Second Street shall stop at Chestnut Street.
3. Chestnut Street. Vehicles traveling on Chestnut Street shall stop at Hwy. 169/Fourth Street.
4. Baker Street. Vehicles traveling south on Baker Street shall stop at the intersection of Locust and Fourth Streets.
5. North Street. Vehicles traveling on North Street shall stop at Fifth Street.
6. Third Street. Vehicles traveling on Third Street shall stop at Chestnut Street.
7. Fifth Street. Vehicles traveling on Fifth Street shall stop at Locust Street.
8. Fifth Street. Vehicles traveling south on Fifth Street shall stop at North Street.
9. Baker Street. Vehicles traveling on Baker Street shall stop at Chestnut Street.
10. Sixth Street. Vehicles traveling on Sixth Street shall stop at Chestnut Street.
11. Eighth Street. Vehicles traveling south on Eighth Street shall stop at Chestnut Street.
12. Eighth Street. Vehicles traveling north on Eighth Street shall stop at Locust Street.
13. Locust Street. Vehicles traveling west on Locust Street shall stop at Eighth Street.
14. Locust Street. Vehicles traveling on Locust Street shall stop at Seventh Street.

15. Sixth Street. Vehicles traveling north on Sixth Street shall stop at Walnut Street.

65.03 FOUR-WAY STOP INTERSECTIONS. Every driver of a vehicle shall stop before entering the following designated four-way stop intersections:

(Code of Iowa, Sec. 321.345)

1. Intersection of Walnut Street and Third Street.
2. Intersection of Seventh Street and Chestnut Street.
3. Intersection of Baker Street and Walnut Street.

65.04 YIELD REQUIRED. Every driver of a vehicle shall yield in accordance with the following:

(Code of Iowa, Sec. 321.345)

1. Eighth Street. Vehicles traveling north on Eighth Street shall yield at Baker Street.
2. Fifth Street. Vehicles traveling south on Fifth Street shall yield at Walnut Street.
3. Laurel Street. Vehicles traveling east on Laurel Street shall yield at Baker Street.

65.05 STOP BEFORE CROSSING SIDEWALK. The driver of a vehicle emerging from a private roadway, alley, driveway, or building shall stop such vehicle immediately prior to driving onto the sidewalk area and thereafter shall proceed into the sidewalk area only when able to do so without danger to pedestrian traffic and shall yield the right-of-way to any vehicular traffic on the street into which the vehicle is entering.

65.06 STOP WHEN TRAFFIC IS OBSTRUCTED. Notwithstanding any traffic control signal indication to proceed, no driver shall enter an intersection or a marked crosswalk unless there is sufficient space on the other side of the intersection or crosswalk to accommodate the vehicle.

65.07 YIELD TO PEDESTRIANS IN CROSSWALKS. Where traffic control signals are not in place or in operation, the driver of a vehicle shall yield the right-of-way, slowing down or stopping, if need be, to yield to a pedestrian crossing the roadway within any marked crosswalk or within any unmarked crosswalk at an intersection.
